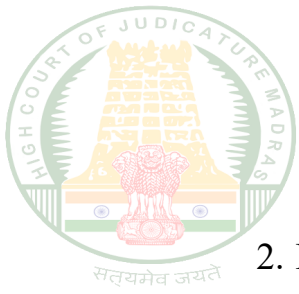

This Writ Petition has been filed to direct the 1st respondent to consider the petitioner's representation dated 21.07.2025.



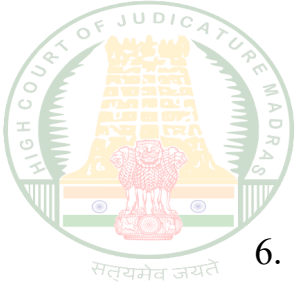
