ORDER

The petitioner, who apprehends arrest at the hands of the respondent police for the offences punishable under *Sections 296(b), 115(2), 118(1) of BNS Act, 2023 r/w Under Section 4 of Women Harassment Act, in Crime*



No.33 of 2026, on the file of the respondent police, seeks anticipatory bail.

2. The case of the prosecution is that the petitioner is the sole accused and the date of occurrence the defacto complainant looked up to see what is what while so the petitioner suddenly assaulted her and also used filthy language and pulled her hair and brutally attacked the defacto complainant. Hence this case.

3. The learned counsel appearing for the petitioner submitted that the petitioner has been falsely implicated in this case and the petitioner has not committed any offence. He seeks this Court to grant anticipatory bail to the petitioner.

4. The learned Government Advocate (Crl. side) appearing for the respondent submitted that the offences committed by the petitioner are serious in nature and there was some wordy quarrel between the petitioner and the defacto complainant, the injured was discharged from hospital.

5. Considering the facts and circumstances of the case, this Court is inclined to grant anticipatory bail to the petitioner with certain conditions.

6. Accordingly, the petitioner is ordered to be released on bail in the event of arrest or on his appearance, on condition that the petitioner shall execute a



bond for a sum of ***Rs.10,000/-(Rupees Ten Thousand only)*** with two sureties each for a like sum to the satisfaction of the ***learned Judicial Magistrate No.1, Attur, Salem District,*** within a period of fifteen days from the date on which the order made ready and on further conditions that:

[a] the petitioner and the sureties shall affix their photographs and left thumb impression in the surety bond and the Magistrate may obtain a copy of their Aadhaar card or bank pass book to ensure their identity.

[b] The petitioner shall deposit a sum of **Rs.5000/-(Rupees Five Thousand only)** non-refundable, to the account of **CANCER INSTITUTE (WIA), maintained with Andhra Bank, Madhya Kailash Branch, bearing SB Account No.149710011005477, IFS Code No.ANDB0001497, Branch Code 1497 and MICR No.600011049** and the receipt of such payment shall be produced before the concerned Magistrate at the time of execution of the bond for the purpose of ensuring the identity.

[c] the petitioner shall report before the respondent police daily at **10.30 a.m., until further orders.**

[d] the petitioner shall not tamper with the evidence or witness either during investigation or trial.

[e] the petitioner shall not abscond either during investigation or trial.

[f] On breach of any of the aforesaid conditions, the learned Magistrate/Trial Court is entitled to take appropriate action against the petitioner in accordance with law as if the conditions have been imposed and



the petitioner is released on bail by the learned Magistrate/Trial Court himself as laid down by the Hon'ble Supreme Court in P.K.Shaji vs. State of Kerala [(2005)AIR SCW 5560].

[g] If the accused thereafter absconds, a fresh FIR can be registered under Section 269 of BNS.
