This Criminal Original Petition has been filed to quash the FIR in Crime No.257 of 2025 on the file of the 1st respondent Police.

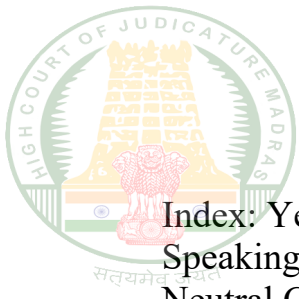
