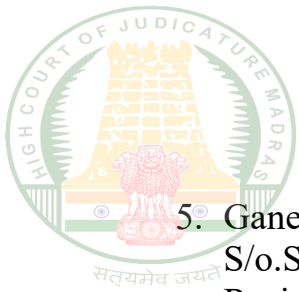

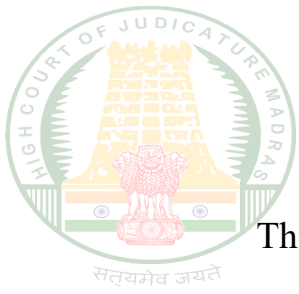

**ORDER**

Without expressing any opinion on the merits of the writ petition, the second respondent is directed to conduct an enquiry on the complaint lodged by the petitioner, after issuing notice to the petitioner and the respondents 3 to 7, and pass appropriate orders on merits and in accordance with law, within a period of two weeks from the date of receipt of a copy of this order.
