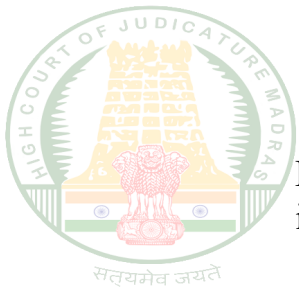

JUDGMENT
