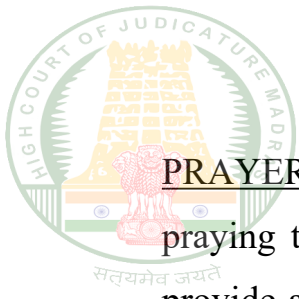

ORDER

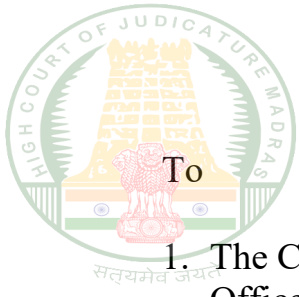
Learned counsel for the petitioner submitted that the relief sought for in the above Writ Petition has become infructuous. He has also made an endorsement to that effect in the Court bundle.
