COMMON ORDER

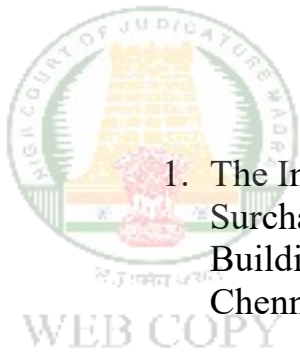
