3.Recording the above submission made by the learned Government Advocate, this Criminal Original Petition stands closed. Consequently, the connected criminal miscellaneous petition is closed.

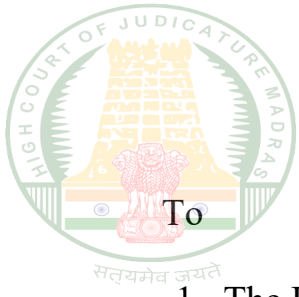
