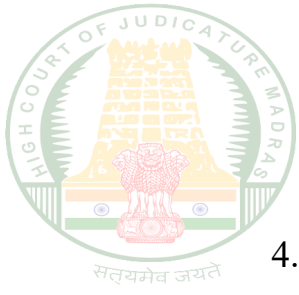

ORDER

By consent, the writ petition is taken up for final disposal at the admission stage itself.

2.The petitioner has filed this writ petition seeking issuance of Writ of Mandamus directing the respondents to grant planning permission to the petitioner's property comprised in R.S.No.23/2D1 and 23/2C situated at Varadareddipalli Village, Gudiyatham Taluk, Vellore District on the basis of the petitioner's application dated 29.11.2025 and representation dated 09.03.2026 within a time frame fixed by this Court.

3.The learned counsel appearing for the petitioner submitted that the petitioner made application dated 29.11.2025 and representation dated 09.03.2026 to the respondents seeking to grant planning permission to the petitioner's property comprised in R.S.No.23/2D1 and 23/2C situated at Varadareddipalli Village, Gudiyatham Taluk, Vellore District, however, there is no response.
