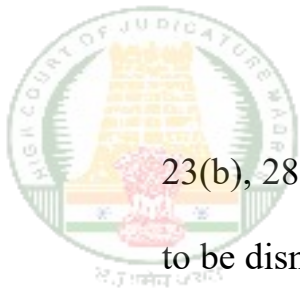

Considering the submissions put forth on either side, considering the fact that the petitioner has no other blood relatives other than her parents who are not alive now, I am inclined to modify the condition imposed in Paragraph No.5 to the effect that "*the petitioner is ordered to be released on bail on her executing a bond for a sum of Rs.10,000/- (Rupees Ten Thousand Only), with two sureties each for a like sum, to the satisfaction of the Principal Special Court under EC and NDPS Act, Chennai.*". The other conditions imposed in the order dated 30.04.2026 in CrI. O.P. No.10329 of 2026 shall remain unaltered. Further, the Magistrate is hereby directed to follow the Rule 14 of Criminal Rules of Practice, while accepting the sureties.

5. Accordingly, the condition is **modified**.
