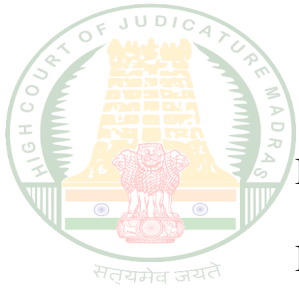

ORDER

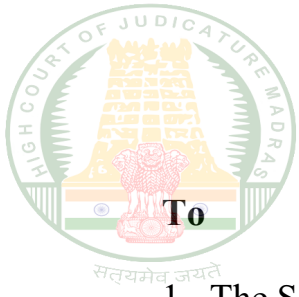
