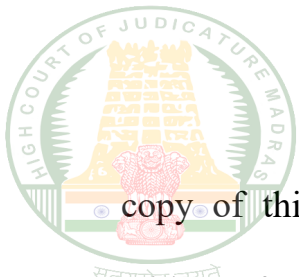

copy of this order, failing which, this petition shall stand dismissed automatically, without further reference to this Court. It is made clear that no application for an extension will be entertained by this Court.

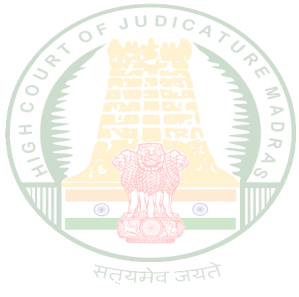
