3. It is seen that while granting anticipatory bail, this Court by an order dated 27.03.2026 in Crl.O.P. No.7814 of 2026, imposed one of the conditions that, the petitioner shall execute a separate bond for a sum of Rs.20,000/- (Rupees Twenty Thousand Only), with two sureties each for a like sum to the satisfaction of the learned Magistrate concerned. To extend the time to comply with the said condition, the petitioner has filed the present petition.
