2. The learned counsel appearing for the petitioner submitted that the second respondent police harassed the petitioner under the guise of enquiry.

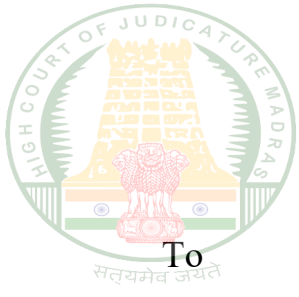
