ORDER

The petitioner, who was arrested on 20.04.2026 and remanded to judicial custody on the same day for the offences punishable under Sections 296(b), 132, 351(3) of B.N.S. and Section 4(1)(a) of the Tamilnadu Prohibition Act, 1937, in Cr.No.262 of 2026 on the file of the respondent police seeks bail.

2 The case of the prosecution is that the when the Sub Inspector of Police and Constable were patrolling within the station limits, found the petitioner was in illegal possession of 25 Government liquor bottles. Hence the case.

3 The learned counsel for the petitioner would contend that the respondent police wantonly registered a false case against the petitioner and he has not committed any offence as alleged by the prosecution. The petitioner was arrested and remanded to judicial custody on 20.04.2026. He would further submit that the petitioner is the sole breadwinner of the family. Hence he prayed that the petitioner may be released on bail.

4 The learned Government Advocate (Criminal Side) would submit that investigation is pending and the offences are grave in nature and the petitioner was arrested on 20.04.2026 and he already involved in three previous cases. Hence he opposed to grant bail to the petitioner.

5 Heard both sides and perused the materials available on record.

6 Considering the rival submissions on either side, nature of

offences and even though there are three previous cases pending, all are not similar in nature, and the period of incarceration undergone by the petitioner, I am inclined to grant bail to the petitioner subject to the following conditions:

[a] Accordingly, the petitioner is ordered to be released on bail on condition to execute a bond for a sum of Rs.10,000/- (Rupees Ten Thousand only) with two sureties each for a like sum to the satisfaction of the learned XIV Metropolitan Magistrate, Egmore, Chennai, and on further conditions that:

[b] the petitioner shall report before the respondent police every Saturday at 10.30 a.m. until further orders.

[c] the petitioner shall not commit any offence similar to the offence of which he is accused, or suspected, or of the commission of which he is suspected;

[d] the petitioner shall not abscond either during investigation or trial;

[e] the petitioner shall not directly or indirectly make any inducement, threat or promise to any person acquainted with the facts of the case so as to dissuade him from disclosing such facts to the Court or

to any police officer or tamper with the evidence;

[f] On breach of any of the aforesaid conditions, the learned Judicial Magistrate/Trial Court is entitled to take appropriate action against the petitioner in accordance with law as if the conditions have been imposed and the petitioner released on bail by the learned Magistrate/Trial Court himself as laid down by the Hon'ble Supreme Court in P.K.Shaji vs. State of Kerala [(2005)AIR SCW 5560].

[g] If the accused thereafter absconds, a fresh FIR can be registered under Section 229A IPC.
