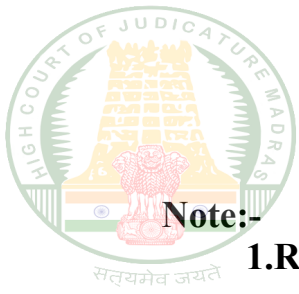
2.Mr.V.Meganathan, learned Government Advocate (Criminal Side) would submit that the petitioners are complying with the conditions regularly.
