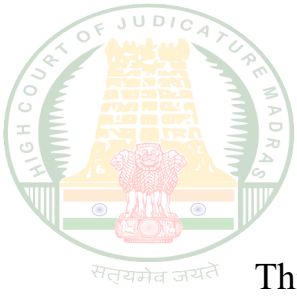

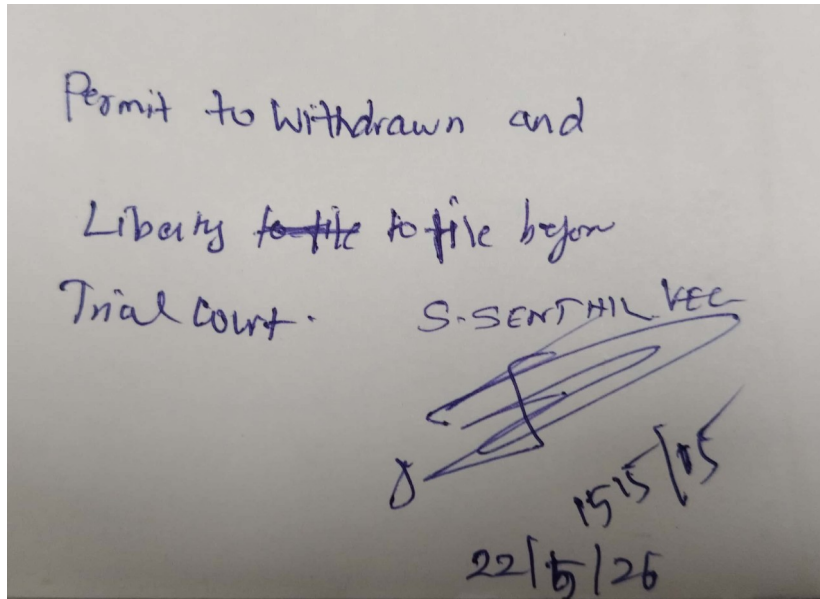


ORDER
