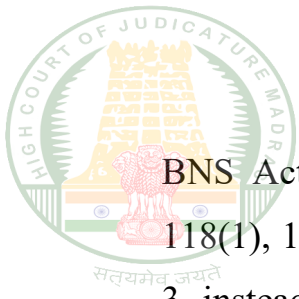

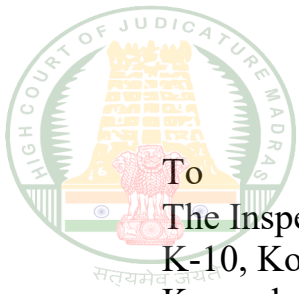
2. Considering the reason stated in the petition and there are typographical error, this Criminal Miscellaneous Petition is allowed.
