The petitioner/wife has sought for transfer of the proceedings filed by the respondent/husband in HMOP No.572 of 2025 on the file of Additional Family Court, Coimbatore to the file of Sub Court, Udumalpet in view of the distance that the petitioner will have to cover/travel to attend the proceedings before the Additional Family Court, Coimbatore. The petitioner is also obligated to take care of minor child, aged four years.

3. I am satisfied with the reasons assigned by the petitioner warranting transfer of the proceedings as sought for by the petitioner/wife.

4. Accordingly, Tr.C.M.P.No.510 of 2025 is allowed and the proceedings in HMOP No.572 of 2025 is withdrawn from the file of Additional Family Court, Coimbatore and the same is transferred to Sub Court, Udumalpet.
