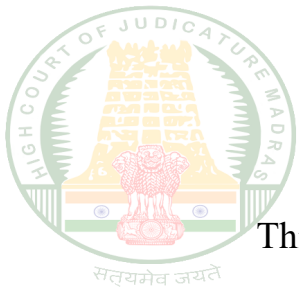

**ORDER**

This petition is filed seeking exemption from surrender following the conviction and sentence imposed in S.T.C. No. 466 of 2019 by the Learned Judicial Magistrate Court, Palladam, Tiruppur, which was subsequently confirmed by the Sessions Judge, Special Court for Trial of Cases under SC/ST (PoA) Act, Tiruppur, in Crl.A. No. 184 of 2024.

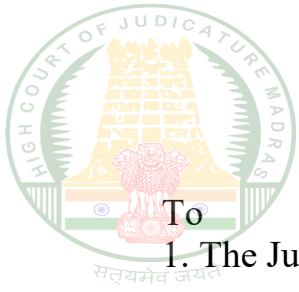
2.Heard the learned counsel for the petitioner and the learned Government Advocate (Crl. Side) for the respondent.

3.Upon hearing both sides and perusing the case materials, this Court finds no compelling or extraordinary grounds to waive the mandatory requirement of surrender prior to the consideration of the Criminal Revision Petition. In the light of the settled legal position and the order passed by this Court in Crl.M.P.No.8777 of 2026 in Crl.R.C.No.1108 of 2026, the statutory mandate cannot be bypassed.

4.Accordingly, this petition seeking exemption from surrender is dismissed.
