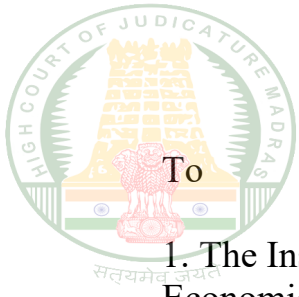
4. Accordingly, this Criminal Miscellaneous Petition stands ordered.
