COMMON ORDER

This petition has been filed seeking an extension of time to comply with the conditions imposed by this Court in the order dated 07.04.2026 passed in Crl.M.P.No.6156 of 2026 in Crl.R.C.No.784 of 2026.

2.It is submitted by the learned counsel for the petitioner that a typographical error has crept into the prayer clause of the petition, wherein the case number has been inadvertently mentioned as "STC No. 747 of 2024" instead of the correct number, "STC No. 1941 of 2022".

3.In view of the submissions made, the Registry is directed to carry out the necessary amendment in the prayer of the main Criminal Revision Case, the miscellaneous petition, as well as in the previous order dated 07.04.2026, substituting "STC No. 1941 of 2022" in place of "STC No. 747 of 2024". After carrying out the said amendments, the Registry is further directed to upload the amended version of the order dated 07.04.2026.

4.The learned counsel for the petitioner further submits that the petitioner requires additional time to execute the necessary sureties before the trial court



as directed earlier, and assigns reasons for the delay.
