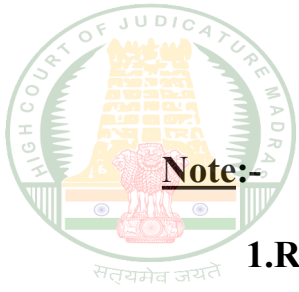
2. Considering the reasons stated in the affidavit filed in support of the petition, this Criminal Miscellaneous Petition is ordered as prayed for.
