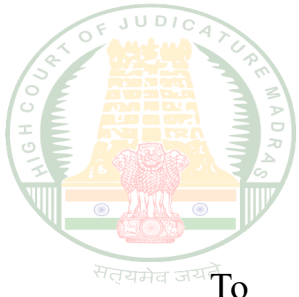
2. The learned Government Advocate (Crl. Side) appearing for the respondent/police would submit that the petitioner is complying with the conditions regularly for a period of 20 days.
