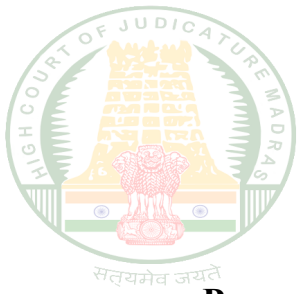

ORDER

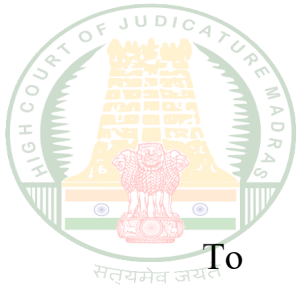
The prayer in the Writ Petition has become infructuous.
