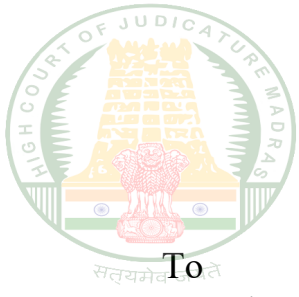
2.The learned counsel for the petitioner states that this writ petition has become infructuous.
