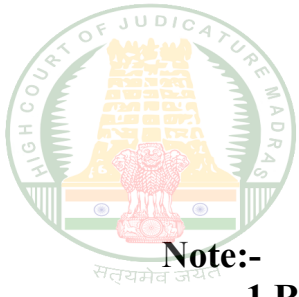
2.Mr.V.Meganathan, learned Government Advocate (Criminal Side) appearing for the respondent would submit that the petitioner is complying with the conditions regularly.
