3.Accordingly, this Criminal Miscellaneous Petition is ordered.

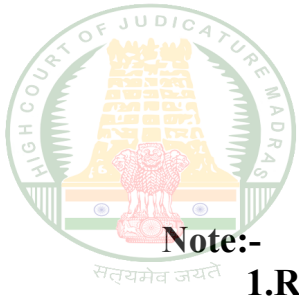
