ORDER

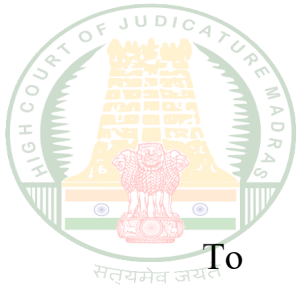
Heard both sides.
