COMMON JUDGMENT

Today, the matters are posted before this Court under the caption 'For Being Mentioned' at the instance of the learned counsel appearing for the appellants.

2. The learned counsel appearing for the appellants submitted that this Court by an order dated 17.04.2026, while partly allowing the Criminal Appeals, directed the respondent to secure the first accused to undergo the remaining period of sentence. However, it was wrongly typed as “to secure the second accused”. Hence he prayed for necessary correction.

3. Considering the above submissions, the last two lines at the end of the paragraph No.15 in the order dated 17.04.2026, in Crl.A.Nos.712 of 2023 & 1015 of 2024 shall read as follows:-
