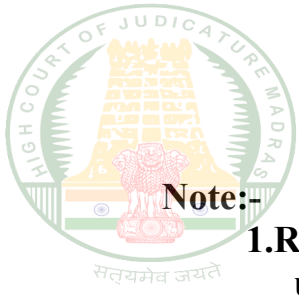
2.It is stated that the petitioner has complied the condition from 11.05.2025 to 18.05.2026 without fail.
