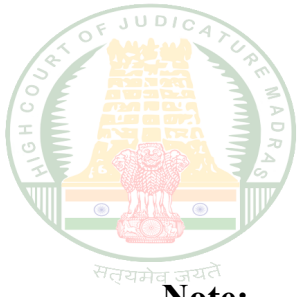
2. Heard both sides.
