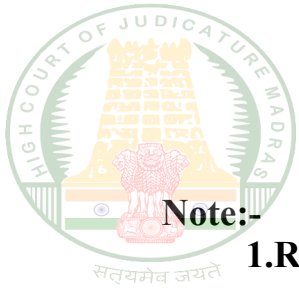
2.The learned Government Advocate (Criminal Side) would submit that the Petitioner is complying with the conditions regularly.
