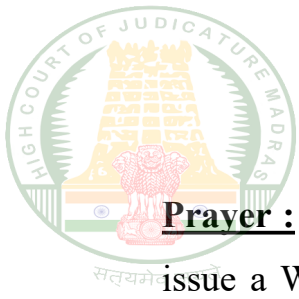

In this regard, he submitted a representation dated 13.01.2026 for referring him to a Medical Board.

In view of the above, the second respondent is directed to consider the petitioner's representation and pass appropriate orders, on merits and in accordance with law, within a period of four weeks from the date of receipt of a copy of this order. Till such time, the petitioner shall continue to be assigned



light duty.
