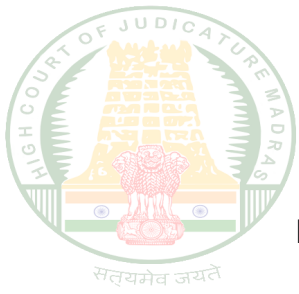

(Order of the Court was made by G.R.Swaminathan J.)

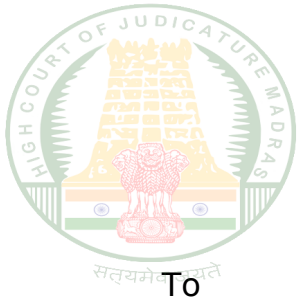
Heard both sides.
