5. The writ petition stands disposed of. No costs.

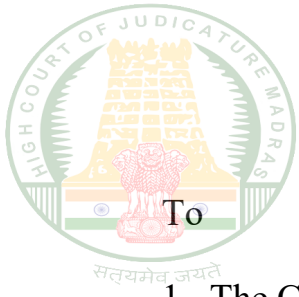
