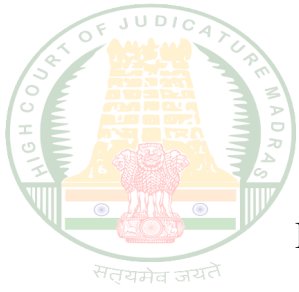

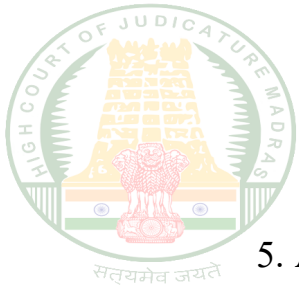
Order
