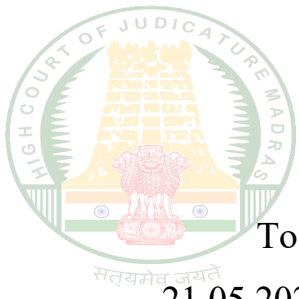

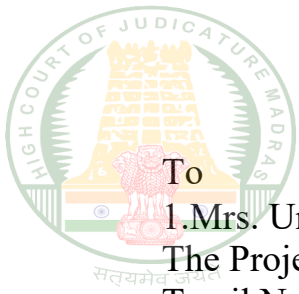
Order
