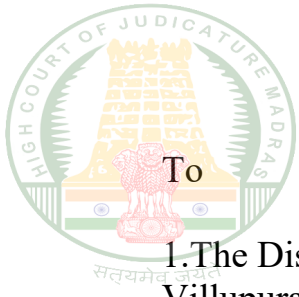
2. A copy of the survey report shall be served on the petitioner herein.
