ORDER

(Order of the Court was made by Dr.G.Jayachandran J.)

The learned Government Advocate appearing the State submitted that the portion of the encroachment made by the petitioner has been removed pursuant to the impugned notice, after considering the representation of the petitioner herein.

2. Since action has been taken following the due process of law, we are not inclined to entertain this Writ Petition and it stands dismissed. Consequently, the connected Miscellaneous Petition is closed. No costs.

3. The learned counsel appearing for the petitioner submitted that no action has been taken so far against neighbours who have also encroached upon



the land. If it is so, the authority shall proceed against the other encroachers also and take appropriate action in accordance with due process of law.
