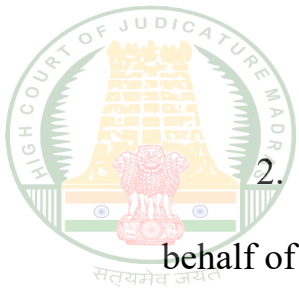

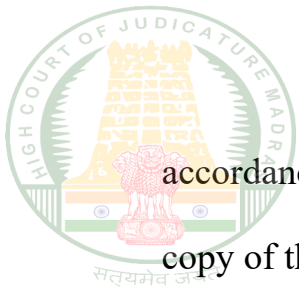
3. By consent of the parties, the main petition is taken up for disposal in the stage of admission itself.
