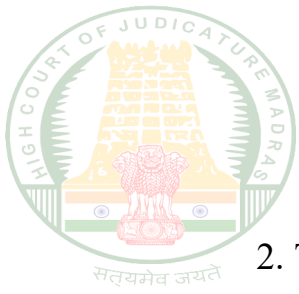

The petitioner, who was arrested and remanded to judicial custody on 05.07.2024 for the alleged offence under Sections 8(c), 20(b)(ii), (c) of NDPS Act, 1985 as amended by Act 9/2001 in Crime No.13 of 2024 on the file of the respondent police, seeks bail.

2. The case of the prosecution is that the petitioner is a native of Tirupura and he was arrested on 05.07.2024 for the alleged possession of 24 kgs of ganja.

3. While considering the earlier bail petitions filed by the petitioner in Crl.O.P.No.11375 of 2025 and Crl.OP.No.19388 of 2025 this Court after considering the various points, dismissed these petitions on 17.04.2025 and 03.09.2025 respectively.

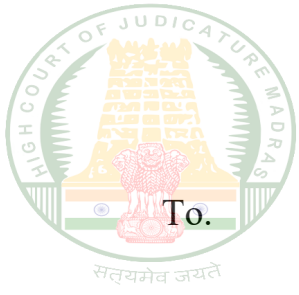
