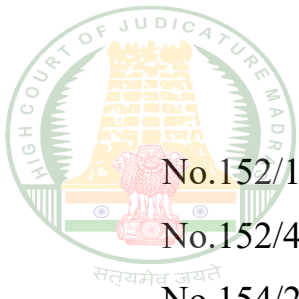

**Prayer:**

Writ Petition filed under Article 226 of the Constitution of India, praying to issue a Writ of Mandamus, directing the respondents 4 and 5 herein to survey



No.152/1, lands measuring an extent of 1-2.00 Hectares, comprised in Survey No.152/4, lands measuring an extent of 0-71.50 Hectares, comprised in Survey No.154/2, as per patta Nos. 119 and 336, under application No.2026/0123/ 33/ 001250 dated 24.03.2026 and lands measuring an extent of 1-43.00 Hectares, comprised in Survey No.149/3 as per patta No.52, under Application No.2026/ 0123/ 33/ 001251 dated 24.02.2026 in Mundiur Village, Kalvarayan Hills Taluk, Kallakurichi District and to measure the boundaries and fix the measurement stone on the edges of boundaries in the above lands with the 6th respondent police protection

### **ORDER**

This writ petition has been filed to direct the respondents to consider the petitioner's application dated 24.02.2026.

2. Ms.Inthu Karunakaran, learned Government's counsel, takes notice on behalf of the respondents 1 to 5 and Mr.Durai Gunasekaran, learned Government Advocate, takes notice on behalf of the 6<sup>th</sup> respondent.

3. By consent of the parties, the main petition is taken up for disposal in the stage of admission itself.



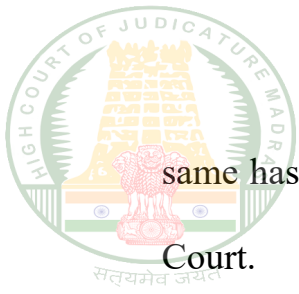
4. The learned counsel for the petitioner would submit that in this case, the petitioner filed an application dated 24.02.2026 before the 4<sup>th</sup> & 5<sup>th</sup> respondents, requesting them to survey the subject land and lay boundary stones therein. However, the said representation was not at all considered by the respondents till date. Hence, this petition.

5. In reply, the learned counsel for the respondent would submit that the petitioner's representation will be disposed of within a period of 8 weeks and hence, she requests this Court to pass appropriate orders.

6. Heard the learned counsel appearing for the petitioner as well as the respondent and also perused the entire materials available on record.

7. In view of the above, without expressing any opinion on the merits of the matter, this Court directs the 5<sup>th</sup> respondent to consider the application filed by the petitioner dated 24.02.2026 and dispose of the same, on merits and in accordance with law, within a period of 8 weeks from the date of receipt of a copy of this order.

8. It is made clear that this order is passed only for the purpose of issuing a direction to the official respondent for conducting survey at the subject land. If there is any dispute with regard to the possession over the said property, the



same has to be decided only by way of filing a suit before an appropriate Civil Court.

9. If any police protection is required at the time of conducting survey, the Revenue Authorities is granted liberty to avail the same by approaching the 6<sup>th</sup> respondent. In such case, the 6<sup>th</sup> respondent shall provide all necessary protection to the Revenue Authorities till the completion of survey at the subject land.

10. With the above directions, this writ petition is disposed of. No cost.
