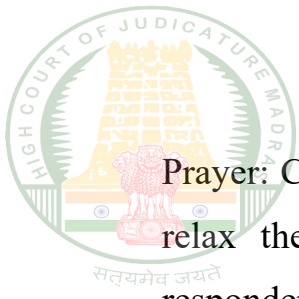

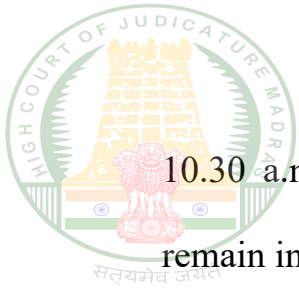

ORDER
