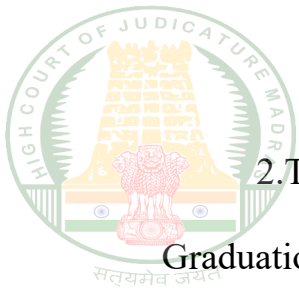

This criminal original petition has been filed to direct the respondent police to complete the investigation and file the final report in Crime No.485 of 2024 pending on the file of the respondent police.



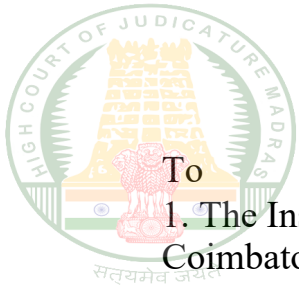
2.The contention of the petitioner is that the petitioner is pursuing his Post Graduation in M.S. Orthopaedics in Coimbatore Medical College Hospital. He is a meritorious student and received appreciations.
