4. With the above direction, this Writ Petition (Criminal) stands disposed of. No costs.

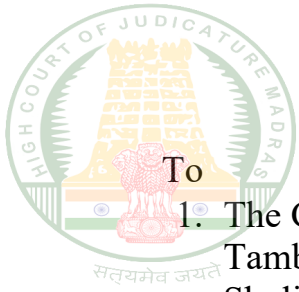
