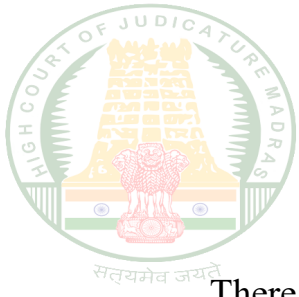
to the respondent to register a First Information Report based on the complaint 28.04.2026.
