Writ Appeal under clause 15 of Letters Patent to set aside the impugned order dated 29.04.2026 passed in W.P. No. 17314 of 2026.

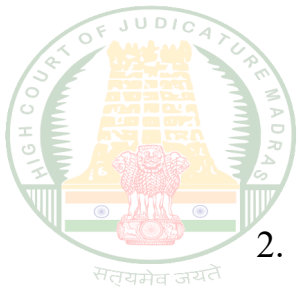
