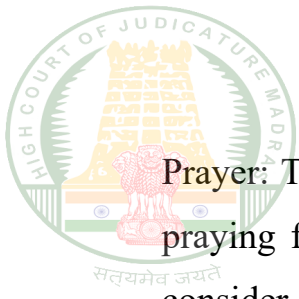

2. Recording the submissions made by the learned counsel for the petitioner, this Writ Petition is dismissed as withdrawn. No costs.

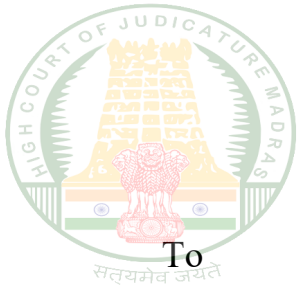
