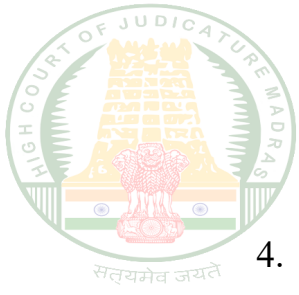

of. No costs.

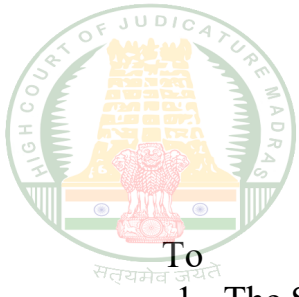
